**GBP Class (Institutional Unhedged Distributing) (ISIN IE00BYVHBS17) (the "Class") is a share class of Polen Capital U.S. Small Company Growth Fund (the "Fund") a sub-fund of Polen Capital Investment Funds plc (the "Company")**

This PRIIP is authorised in Ireland and regulated by the Central Bank of Ireland. The PRIIP Manufacturer and the Management Company is Amundi Ireland Limited (the "Manager") which is authorised in Ireland and supervised by the Central Bank of Ireland. Polen Capital Management, L.L.C is the Investment Manager appointed to the Fund.

**WHAT IS THIS PRODUCT?**

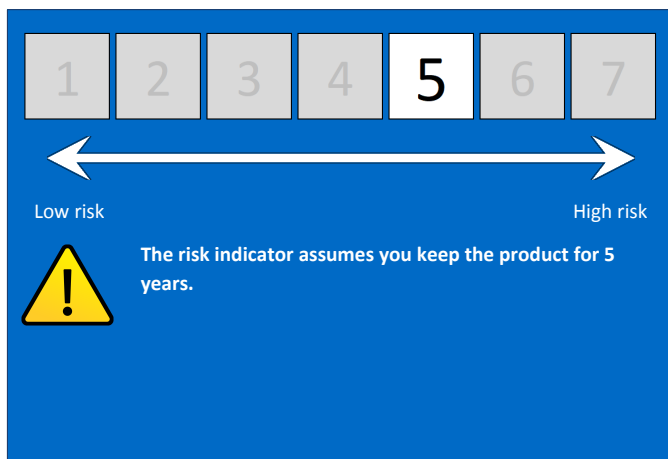
The Class is a share class of the Fund which is a sub-fund of the Company, an open-ended umbrella investment company with variable capital and segregated liability between Funds incorporated with limited liability in Ireland under the Companies Act 2014 with registration number 522617 and established as an undertaking for collective investment in transferable securities pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011 (S.I. No. 352 of 2011), as amended (the "UCITS Regulations").

Subject to the conditions set down in the Prospectus, investors may switch their shares in the Fund or Class for shares in a different class of the Fund or another Fund or Class. Please refer to the section entitled "Conversion of Shares" in the Prospectus and Fund Supplement for further details. The Prospectus of the Company and the periodic reports are prepared for the entire Company. There is no fixed term for this Fund.

The Fund's objective is to achieve long term growth of capital. The Fund will invest primarily in a focused portfolio of high quality common stocks of small companies (market capitalisations within the range of the market capitalizations of companies in the Russell 2000 Index and the S&P Small Cap 600 Index on a rolling three-year basis at time of purchase) which are listed or traded on recognised exchanges in the United States of America. The Fund may from time to time also purchase the common stock of companies whose shares are listed or traded on Recognised Exchanges in the United States of America which have a market capitalisation outside of the small company definition if the Investment Manager is of the opinion that the stock represents a particularly attractive investment opportunity. The Fund may also invest in American Depositary Receipts where deemed appropriate by the Investment Manager in order to achieve the investment objective of the Fund. These stocks are selected by the Investment Manager on the basis that they operate with a sustainable underlying competitive advantage among companies in their respective industries or sectors. For example, the Investment Manager will select securities which it feels have consistent and sustainable high returns on capital, vibrant earnings growth, robust free cash flow generation, strong balance sheets and competent and shareholder-oriented management teams. Where an appropriate investment opportunity is not available, the Fund may also hold and maintain ancillary liquid assets, including cash and cash equivalents (such as certificates of deposit) and Money Market Instruments (such as commercial paper, bankers acceptance and other short-term debt securities). The Fund may also invest up to 10% of its Net Asset Value ("NAV") in aggregate in other open-ended collective investment schemes. The Fund may use a limited number of simple derivative instruments for hedging purposes (such as currency swaps and currency forwards). It is not intended that the Fund will be leveraged as a result of its use of derivatives. The Fund is considered to be actively managed in reference to the Russell 2000 Growth Index and the S&P Small Cap 600 Index (the "Benchmarks") by virtue of the fact that it uses each of the Benchmarks to define the characteristics of the securities held by the Fund. Certain of the Fund's securities may be components of and may have similar weightings to the Benchmarks. However, the Fund may be wholly invested in securities which are not constituents of the Benchmarks. The Fund may also use the Russell 2000 Growth Index for performance comparison purposes, however it is not used as a performance target. The Shares that you will hold in the Fund are distributing Shares. This means that the Class aims to distribute available income from the Fund's investments in the form of a dividend which will be paid to you on an annual basis. You may sell shares in the Fund by submitting an application to the Fund's Administrator before 2 p.m. (Irish time) on any Business Day and/or such other day or days as may be determined by the Directors of the Company. The Company's depository is The Bank of New York Mellon SA/NV, Dublin Branch. **WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?**



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact our capacity to pay you.

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

The recommended holding period of 5 years is based on the liquidity profile of the Fund as well as the risk profile of the underlying assets. In order to divest/redeem from the Class you can send a completed signed redemption request in the form available from the Administrator in accordance with the provisions of the Supplement for the Fund outlined in the section entitled "Redemption of Shares" prior to 2p.m. (Irish time) on any Business Day (as defined in the Prospectus). and/or such other day or days as may be determined by the Directors of the Company. In order to prevent excessive and disruptive trading practices the Directors may impose a redemption fee not exceeding 3% of the NAV of Shares being redeemed for the benefit of the Fund.
